RE: **RECALL/PRODUCT HOLD**

Dear Mr. Kette:

I represent Rising Dough Bakery and have been requested to communicate with you about a Product Hold that requires immediate action on your part. The Product Hold applies to all Banana Nut Muffins (Rising Dough Item # 41255 – Dot Foods Item # 475828) and Cranberry Muffins (Rising Dough Item # 41259 – Dot Foods Item # 475829) from Rising Dough Bakery.

It has been determined that the labels on the Cranberry Muffins and Banana Nut Muffins have omitted certain information. The ingredient "walnuts" is not on the Cranberry Muffin label. Although the ingredient "walnuts" does appear on Banana Nut Muffin label, it is not reflected in the Allergens list. Because of these omissions, it is important that you place an immediate hold on each of these products at your facility(ies). Rising Dough Bakery already has placed a hold on these products at its own facility.

In addition to placing a hold on these items, Rising Dough Bakery recommends the following:

1. Rising Dough Bakery will remove all inventories of muffins bearing the above-referenced item numbers from your facility(ies) by September 28, 2010;

2. You should immediately notify all Dot Food drivers who do or may have the above-referenced products ready for delivery not to deliver them and to place their own holds on the items;

3. Rising Dough Bakery will produce and ship to you new product with compliant labeling as soon as possible.
