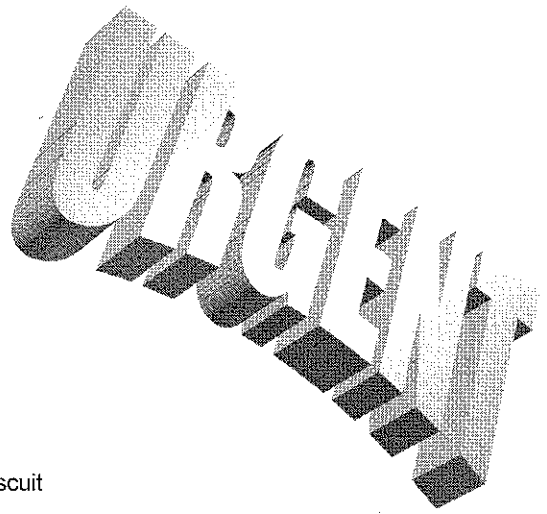

Lettieri's has initiated a voluntary recall of the products and date codes listed above.

Lettieri's has determined that these products contain MSG (monosodium glutamate), which is not declared on the label. MSG is used as a flavor enhancer in a variety of foods prepared at home, in restaurants, and by food processors. Some persons who have eaten foods containing MSG have reported adverse reactions. To date, no illnesses or adverse reactions have been associated with any of these products.

Lettieri's is taking an extremely proactive approach to protecting the public by recalling the products produced at our facility. Even though we have not received any complaints on the products, we are undertaking this action in cooperation with the Food and Drug Administration and the Food Safety Inspection Service of the United States Department of Agriculture.

Please follow the steps listed below immediately.

- 1.) **IMMEDIATELY discontinue selling all of the products listed above.**
- 2.) **IMMEDIATELY remove all products from the display areas. (DO NOT DISPOSE OF PRODUCT.)**
- 3.) Place all products in the freezer and segregate product until further notice. **(DO NOT DESTROY!)**
- 4.) Please fill out & fax back the inventory verification form. Fax to the following #: 605-336-1425. **(DO NOT DESTROY!)**
- 5.) A Lettieri's representative will call back to coordinate the timing, and describe the steps that need to be taken to ensure the proper method of destruction, and verification, are completed during the destruction of the remaining product. This will ensure proper credit is received.

In addition, if you may have further distributed this product, please identify your customers and notify them at once of this product recall.
