Kellogg Company is voluntarily conducting a Class II recall of a limited number of packages of ***Morningstar Farms Corn Dogs Veggie Dogs*** and ***Morningstar Farms Mini-Corn Dogs Veggie Dogs***.

No other varieties or manufacturing code dates of *MorningStar Farms* products are affected by this recall.

Depth of Recall: Warehouse and Store Level

Reason for Recall: We are taking this precaution after a routine regulatory agency audit of a co-manufacturer’s operation indicated that these products may have been packaged in an environment that was not in full compliance with regulations governing current good manufacturing practices. In discussions with the FDA, they advised that this be classified as a Class II recall, which the agency defines as a situation where the probability of serious adverse health consequence is remote.
