

URGENT: FOOD RECALL

Dear Customer:

Due to the recently announced expanded recall of peanuts, we are writing to advise you that we have taken the precautionary measure of voluntarily recalling all products containing peanuts produced at Peanut Corporation of America's Blakely, Georgia facility. The only Ocean Spray products shipped to you that are impacted are:

1.75 oz Fruit and Nut Trail Mix

48 oz Fruit and Nut Trail Mix



PCA is the subject of an ongoing FDA investigation concerning the recent salmonella outbreak. The recalled products contain peanuts that were manufactured by PCA and that were supplied by PCA to Ocean Spray's third party contract packer for its Fruit and Nut Trail Mix products

Ocean Spray's 6-ounce Fruit and Nut Trail Mix and all sizes of its Chocolate Trail Mix products do not contain nuts from PCA and are not affected by this recall.

As you know, product quality is of paramount importance for Ocean Spray. Our customers and consumers rely on the Ocean Spray brand day in and day out. For this reason, we wanted to make sure you understood the background underlying this issue.

No illnesses or adverse effects have been reported regarding these products. As soon as FDA began its investigation of the PCA facility, the contract packer changed suppliers of its peanut ingredients for these products.

Ocean Spray is advising Customers to remove the Fruit and Nut Trail Mix 1.75-ounce and 48-ounce recalled products from its shelves and destroy these products under standard protocol and return to Ocean Spray an inventory listing of products so destroyed along with certificates of destruction.
