Attached you will find a document announcing that the FDA has issued a voluntary recall for all products produced out of the Peanut Corporation of America, Plainview, TX plant. The recall is for all products produced from January 1<sup>st</sup>, 2007 to February 10<sup>th</sup>, 2009. This notification is separate from the recall issued by the FDA for the Blakely, GA plant of Peanut Corporation of America.

Unfortunately, Palmer Candy did purchase some roasted peanuts from Peanut Corporation of America during the time period shown above. The roasted peanuts were used for the production in some of our peanut clusters. Our records show that a portion of the affected product was shipped to you in some fashion. Please see the attached spreadsheet for the specifics.

Please instruct your customers, store personnel or retail customers to remove any and all inventory of the items from the shelves and pegs. If you are a wholesale/distributor please be sure to notify your retail customers of this recall and the proper steps to take.

After inventorying the product please have it disposed of immediately. Attached you will find a Fax-Back form for your use. Once the form is completed, please fax to the number provided and a credit will be issued to your account.

We apologize for any inconvenience this recall may cause. Even though, no consumers have confirmed any illness due to peanuts, their safety is our number one concern. Please do not hesitate to contact us if you have any questions or concerns.
