

**To our valued RETAIL CUSTOMERS:**

We are notifying you that Premier Nutrition is expanding the date range of its previously announced precautionary, voluntary nationwide recall of select Twisted and Titan Chocolate Peanut Butter Flavor branded bars, due to the recent expansion of a potential *Salmonella* Typhimurium contamination concerning peanut butter manufactured by Peanut Corporation of America (PCA) at its Blakely, Georgia facility. Only these two Premier Nutrition brands are affected by this recall, and of these two, only select variations are affected. **All other brands and products of Premier Nutrition remain unaffected by the voluntary product recall.**

Premier Nutrition is now advising business, customers and consumers that all **TWISTED** and **TITAN** (Chocolate Peanut Butter flavor) nutrition bars with "**Best By**" dates **Between JUN 01, 2008 and JAN 09, 2010**, in the specific sizes and flavors indicated below, are included in the expanded recall.

The following products are potentially affected and are subject to the recall:

- TWISTED Bars, Vanilla flavor with “best by” dates **JUN 01 2008A (June 1, 2008)**, through JAN 09 2010A (January 9, 2010)
- TWISTED Bars, Chocolate flavor with “best by” dates **JUN 01 2008A (June 1, 2008)**, through JAN 09 2010A (January 9, 2010)
- TWISTED Bars, Peanut Butter flavor with “best by” dates **JUN 01 2008A (June 1, 2008)**, through JAN 09 2010A (January 9, 2010)
- TWISTED Variety Packs dated **06/01/08 (June 1, 2008)** through 01/09/10 (January 9, 2010) sold in the United States at Sam’s Club and Costco locations;
- TITAN Bars, Chocolate Peanut Crunch flavor, 80g size with “best by” dates **JUN 01 2008A (June 1, 2008)** through JAN 09 2010A (January 9, 2010).
- TITAN Bars, Chocolate Peanut Crunch flavor, 25g “free sample size” with “best by” dates **JUN 01 2008A (June 1, 2008)** through JAN 09 2010A (January 9, 2010)

These Premier Nutrition products were manufactured by a contract manufacturer which received several batches of peanut butter from PCA. *Salmonella* Typhimurium has NOT been found in ANY Premier Nutrition products and there is no specific evidence that Premier Nutrition's products are contaminated; however, the Company is taking this voluntary action because it is concerned with the health of persons who have consumed or may consume these products due to the information released by the PCA. *Salmonella* is an organism that can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with *Salmonella* often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with *Salmonella* can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.

The Company is advising all customers, including you, to contact Premier Nutrition to receive instructions for returning or destroying the product. Please contact Bob Gilbert, Vice President of Sales, Premier Nutrition, at (760) 929-9995.

The Company regrets having to take this action, but believes it is necessary to ensure the complete safety of its customers and consumers. Again, this voluntary recall has only been initiated with respect to the specific variations of TWISTED bars and TITAN bars identified above; all remaining products of Premier Nutrition are unaffected by the recall. The Company is working closely with the FDA and the Company's supplier in the recall process and is committed to the quality and integrity of its products.
