**DESCRIPTION OF THE PROBLEM**

Zachary Confections has initiated this voluntary recall in response to an expanded recall by Peanut Corporation of America (PCA). PCA's expanded recall now includes all peanuts and peanut-related products from PCA's Blakely, Georgia plant from January 2007 to present. The FDA is investigating an outbreak of Salmonella targeted at PCA's Blakely plant.

Salmonella is an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy persons infected with Salmonella often experience fever, diarrhea (which may be bloody), nausea, vomiting and abdominal pain. In rare circumstances, infection with Salmonella can result in the organism getting into the bloodstream and producing more severe illnesses such as arterial infections (i.e., infected aneurysms), endocarditis and arthritis.

**IMPORTANT INSTRUCTIONS**

- ***Immediately Remove*** all products described above from your retail shelves.
- ***Immediately Cease Distributing*** all products described above.
- If you have previously distributed any of the products described above, ***Immediately Commence a Sub-recall*** of these products.
- ***Promptly Destroy*** all products described above that are in your possession.
- ***Promptly Complete and Return*** the enclosed Fax-Back form that is included within this URGENT FOOD RECALL NOTICE.
