Please be advised that Conagra Brands, in cooperation with the U.S. Department of Agriculture (USDA), is voluntarily recalling 13,128 cases of Evol Cilantro Lime Chicken Burrito product due to the potential presence of an undeclared egg allergen in the product. The presence of this undeclared allergen occurred because a limited number of breakfast burritos containing eggs were inadvertently packed into the Evol Cilantro Lime Chicken burrito packaging.

There have been no confirmed reports of adverse allergic reactions due to consumption of this product. Consumers with questions about the product should contact Conagra Brands Consumer Care at 1-888-849-6243 from 9AM-5PM CST Monday through Friday.
