Re: Voluntary Recall of Certain Bakery Products Due to Possible Presence of Tiny Fragments of Metal Mesh Wire

Give and Go Prepared Foods Corp. initiated a voluntary recall today of certain bakery products sold in Canada and the United States due to the potential presence of tiny fragments of metal mesh wire. The recall commenced following notification by an ingredient supplier of the possible contamination in a supplied ingredient.
